#### The Consulate Interview

The final part of the visa petition process is a face to face interview between a Consular official and your Fiancee or Spouse. This interview is usually very brief and direct. Many interviewees feel the consular official insensitive, cold, even rude.

The official is tasked to look for fraud. This is the last hurdle before the visa is issued and the last chance for the Consulate to catch any irregularities that were not spotted before.

He plans to determine whether in "his opinion", the Fiancee is of good character, and the relationship is genuine. The official may ask her a number of questions on her background and the relationship. He is seeking to trip her up to catch "sham marriages" by couples who fraudulently marry solely for the purpose of obtaining the visa.

The time leading up to the interview can be very stressful for the Fiancee. On one hand she is nervous about saying something wrong, and on the other hand, awakens to the
